



## Automatic Coverage Renewal is Ending for CHIP/CHIP Perinate Members

### Background Information

In response to the COVID-19 pandemic, the Texas Health and Human Services Commission (HHSC) temporarily waived the renewal requirements for CHIP programs and automatically extended coverage from April 2020 through June 2021. Beginning in July 2021, that automatic renewal period is ending for CHIP and CHIP Perinate members. (Note: Automatic extension of Medicaid coverage is continuing at this time.)

Parkland Community Health Plan is making a concerted effort to notify members of these upcoming changes – and we’d appreciate your help in that effort! You may get questions from patients about the renewal process and what it means for them – see below for some information on the timeline and process for renewing CHIP and CHIP Perinate coverage.

### Renewal Timeline

Members will receive renewal packets in the mail from HHSC about 90 days before their application is due (the envelope will be marked “time sensitive”). Once they receive the packet, they will have 30 days to complete their application.

Current renewal dates for CHIP and CHIP Perinate coverage are listed below:

There is no extension for CHIP or CHIP Perinate members whose coverage is schedule to end between July 31, 2021 and September 30, 2021. No special notice will be sent to these members, as the extension does not apply to them.

### Renewal Process

CHIP and CHIP Perinate members have multiple ways to check their status or find answers to their questions about renewal:

- They can check their renewal status or submit a renewal application through their YourTexasBenefits.com account.
- They can also call 2-1-1 to ask questions about the renewal process or get help submitting their application.
- Members can receive text or email alerts for their renewal notices by logging in to YourTexasBenefits.com and signing up for alerts under “Alert Settings.”
- They will need to renew their coverage even if nothing has changed from their previous application.
- If a member’s renewal due date has passed, they must submit a new application for benefits.
- Depending on the member’s income, they may have to pay an application fee when renewing (application fees are \$50 or less per family, per year).
